9 enacted Ordinance Number 10-0419 codifying the Ordinances of Jefferson County,
10 Missouri, including the Erosion and Sediment Control / Stormwater Management Design
11 Manual; and,

12 **WHEREAS**, upon enactment of Ordinance Number 10-0419, the Erosion and
13 Sediment Control/Stormwater Management Design Manual became codified as Title V,
14 Chapter 505 of the Code of Ordinances of Jefferson County, Missouri; and,

15 **WHEREAS**, amendments have been prepared to Title V, Chapter 505 of the
16 Code of Ordinances of Jefferson County, Missouri: Erosion and Sediment Control /
17 Stormwater Management Design Manual; and,

1 **WHEREAS**, the proposed amendments are recommended to clearly define the
2 County's design criteria and requirements for detention basins; channel protection
3 volume; and dedicated conservation easement; and,

4 **WHEREAS**, the Stormwater Division of the Public Works Department
5 recommends new code changes to be included in the 2022 Stormwater Code amending
6 current detention basin criteria. The Current code requires detention basins to be designed
7 for 2 and 10-year storm event. The County will require that detention basins be designed
8 to accommodate a 2 and 100-year storm event unless a variance is approved by the Public
9 Works Director. This will require a larger volume of stormwater to be maintained onsite
10 and released at a slower rate for major frequency storms.

11 **WHEREAS**, the Stormwater Division of the Public Works Department
12 recommends new code changes to be included in the 2022 Stormwater Code to include a
13 provision for channel protection volume criteria. The current code does not have a
14 requirement that accounts for channel protection volume; and,

15 **WHEREAS**, the Stormwater Division of the Public Works Department
16 recommends new code changes to be included in the 2022 Stormwater Code to include a
17 provision for requiring stream buffers in future proposed developments into areas of
18 conservation that are to be recorded on the plats of the developments. The current code
19 does not have a requirement for dedicated conservation easement; and,

20 **WHEREAS**, the Jefferson County, Missouri, Council finds that it is necessary
21 and in the best interests of the citizens of Jefferson County to adopt amendments to the
22 Stormwater Design requirements / Stormwater Management Design Manual as

2 copy of the December 10, 2021 supplement is attached hereto as Exhibit 1a; and,

3 **WHEREAS**, the County Clerk has verified that the Petition complies with the
4 requirements of the CID Act; and,

5 **WHEREAS**, a public hearing, duly noticed and conducted as required by and in
6 accordance with the CID Act, was held at the Jefferson County Administration Center, 729
7 Maple Street, Hillsboro, Missouri 63050 at 6:30 P.M. on January 10, 2022, by the Jefferson
8 County Council (the “Council”); and,

9 **WHEREAS**, copies of notices to property owners in the proposed district are
10 attached hereto as Exhibit 2 (which contains three sub-exhibits, lettered A, B, and C); and,

11 **WHEREAS**, the Affidavit of Publication is attached hereto as Exhibit 3; and,

12 **WHEREAS**, a survey of Marriott Lane is attached hereto as Exhibit 4; and,

8 Section 2. The District is hereby established for the purposes set forth in the
9 Petition and shall have all the powers and authority authorized by the Petition and by the
10 CID Act, including, but not limited to, the powers authorized by Section 67.1461 of the CID
11 Act.

12 Section 3. Subject to all the limitations, ballot, and voting requirements of
13 Section 67.1545 of the CID Act, the District may impose a sales and use tax up to one percent
14 (1%) on all non-exempt retail sales made in the district which are subject to taxation pursuant
15 to Sections 144.010 to 144.525, RSMo., except sales of motor vehicles, trailers, boats or
16 outboard motors and sales to public utilities and providers of communications, cable or video
17 services. In no event shall the sales and use tax exceed one percent (1%) in accordance with
18 Section 67.1545, RSMo.

19 Section 4. Pursuant to Section 67.1451.5 of the CID Act, the Jefferson County,
20 Missouri, Executive hereby appoints and the Council hereby consents to the initial
21 appointment of the Board of Directors of the District as follows:

20 **WHEREAS**, on December 27, 2021, before the Jefferson County, Missouri,
21 County Council (“Council”), the Petition to Vacate came on for hearing; and

1 **WHEREAS**, the ordaining legislation with the said Petition attached thereto was
2 read for the first time, by title, and in open session of the Council on December 27, 2021,
3 at the regularly scheduled meeting of the Council at 6:30 p.m., in accordance with the
4 Council Rules, the Home Rule Charter of Jefferson County (“Charter”) and was read
5 thereafter two additional times, as well as in accordance with the Charter and Section
6 71.270 RSMo., and prior to full passage by the Council; and,

7 **WHEREAS**, the Council finds that the Petitioner is the only owner of the real
8 estate whose lands are touched by the Road Easement proposed to be vacated; and

9 **WHEREAS**, the Council further finds that no cause has been shown to the
10 Council why the vacation of the portion of West Imperial Drive should not be ordered;
11 and

12 **NOW, THEREFORE, BE IT ENACTED BY THE JEFFERSON COUNTY,**
13 **MISSOURI, COUNCIL, AS FOLLOWS:**

14 Section 1. Having so found, the County Council orders that portion of West
15 Imperial Drive shown and described in Exhibits A & B to the Petition to Vacate lying in
16 U.S. Surveys 1303 & 2005, Township 42 North, Range 6 East Of The Fifth Principal
17 Meridian, in Jefferson County, Missouri, and being described as follows:

18 Being part of West Imperial Drive, a 30’ Wide Roadway located in
19 STOVESAND HILLS SUBDIVISION THREE (3), a subdivision in Plat Book 14, Page
20 15B of the Jefferson County land records and being more particularly described as
21 follows:

22

BEGINNING at the intersection of the West line of Lot Five (5) of STOVESAND HILLS SUBDIVISION THREE (3) with the Southeast right of way of the West Outer Road, being part of the Missouri State Highway I-55 right of way; thence along said West line of Lot Five (5) and a continuation thereof along the West line of Lot Four (4) of said subdivision, South 09°02'35" West, a distance of 178.39 feet to the intersection of said line with the North line of a tract conveyed to the State Highway Commission; thence along said North line, North 81°55'31" West, a distance of 30.00 feet to the intersection of said North line of the State Highway Commission tract and the East Line of Lot Fourteen (14) of the aforesaid STOVESAND HILLS SUBDIVISION THREE (3); thence along the East line of Lot Fourteen (14), North 09°02'35" East, a distance of 148.01 feet to the intersection of said East line with Southeast right of way of the aforesaid West Outer Road; thence along said Southeast right of way, along a curve to the right, having a radius of 659.30 feet and being subtended by a chord which bears North 53°12'33" East 43.06 feet, for an arc distance of 43.07 feet to the POINT OF BEGINNING, containing 0.11 acres, more or less, according to a survey conducted by Govero Land Services, Inc., during the month of March 2005

shall be and is hereby vacated.

Section 2. The Petitioner shall be responsible for filing this ordinance with the Office of the County Recorder of Deeds. This shall be at Petitioner's cost.

Section 3. This ordinance shall likewise be kept on file with the County Clerk of Jefferson County, Missouri.

1 Section 4. This ordinance shall be in full force and effect from and after its
2 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
3 shall not affect the remainder of this Ordinance.
